




WHAT WE DO

Giving World (GW) was established in 2001 with a single mission: to deliver life essential supplies to people in need.

Our simple solution to fight poverty and reduce waste to landfill, helps to solve two of the most relevant problems that we face in the UK today.

We save brand-new, business surplus consumer products from landfill: life essentials such as shampoo, bedding, nappies, washing powder, and clothing, among many other items.

And we give these for free to

vulnerable children and young people, homeless people, those suffering from additions or mental



health problems, and lonely, elderly and disabled people.

We help more than 300,000 people by providing over 1 million essential items, annually.

It currently costs us **58p** for a **single intervention of goods** at the point of need.

WHY WE DO IT

Poverty in the UK is huge. We are the 7th richest nation but we have the highest rate of child poverty in the industrialised world. When we think of poverty we often think that it's a problem that exists overseas, we don't think that a child could be starving right here in the UK.

Yet of the 14.3 million people living in poverty in the UK, 4.6 million of them are children. Relying on food banks, skipping meals and borrowing money means their energies are consumed in the struggle to survive.

At the same time as so many people are struggling to obtain the essential everyday items they need, UK businesses produce £2 billion worth of surplus goods every year, much of which is sent to landfill as waste when it could be provided to those in need.

Poverty begets poverty.

It's a fact that by the time a child living in poverty is 6 he or she is 3 times more likely to live their whole life in poverty.




If nothing is done, the most vulnerable in our society will continue to go without basic supplies and the cycle of poverty will persist.

OUR VISION

A society in which no one is in want because nothing is wasted.

PUBLIC BENEFIT

Giving World's only mandate is to help people in need. There is no charge for our projects and our social enterprise gifts 100% of profits to the charity.



OUR PROJECTS

Alongside our core **Life Essential Supplies** project, our small team of 8 staff (7.5 FTE) also deliver two further projects.

GIFTED

GIFTED (Get Inspired For Training, Employment & Development) is a therapeutic skills development programme for young people and adults with



complex needs: physical disabilities, learning difficulties, or mental health needs.

GIFTED empowers beneficiaries to work as a team in a simulated warehouse environment. They process products before distribution to other vulnerable people. In doing so they overcome complex and significant barriers to confidence, personal motivation, self-esteem and gain important employability skills.

Each year GIFTED trains over 100 vulnerable people.

PCP

Personal Care Packs (PCP) is our social enterprise. We supply NHS Trusts, hospitals, hospices and care homes with customised patient care packs, distributed by the hospital for free to vulnerable patients admitted into care.

Each year we produce and sell over 90,000 care packs.

100% of profits are gifted to the charity, contributing up





OUR THEORY OF CHANGE

EVERAGE THE POWER OF SURPLUS GOODS

Mayborn Group, owner of the Tommee Tippee baby products brand, works with Giving World.

A spokesperson said:

"The process of finding a wide range of suitable beneficiaries to distribute our surplus to is time consuming and expensive. Giving World offers a completely managed and trusted solution to our problem. We are able to ensure protection of our brands and move items out quickly and directly to those people who genuinely cannot afford these high quality, yet life essential items. We save time and money by using Giving World and we are delighted that our surplus stock is useful for teenage parents and low income families around the country."

ULFIL ESSENTIAL NEEDS

Angels and Monsters has supported Rihanne, a single teenage parent experiencing anxiety and loneliness, who was living with her mum. Rihanne has regularly received goods from Giving World such as baby bottles and equipment and baby clothes for her daughter, alongside toiletries, underwear and warm clothing. She said:

"I had money issues but the items from Giving World have helped me to budget so I can pay for food shopping. Receiving the goods helps me as I always struggle so it means I can use my money for other bills."

NSPIRE COMMUNITY ACTION

We have created a network of charitable distribution partners. Angels and Monsters for example is a charity offering training and support to young parents, together with on-site childcare, located in an area ranked in the top 10% of deprivation. The Centre Manager said:

"We receive many items from Giving World such as baby products and equipment, toiletries, household cleaning items, underwear and many more. These items are greatly appreciated by the parents as often their money does not stretch far enough for them to comfortably afford these things. It means there's one less thing for them to stress about."

T RANSFORM LIVES

The regular goods from Giving World meant Rihanne was able to move into her own flat and with DIY equipment also received from Giving World, Rihanne has been able to decorate her flat for herself and her daughter. Rihanne said:

"We feel more secure and confident since receiving the items from Giving World. I can look after my daughter and have now made loads of friends. I plan on doing a hairdressing course so I can get a job."



It is impossible to overstate the impact the goods have on our beneficiaries.

We have powerful stories of making low incomes stretch; preventing debt and highrisk loans by providing household essentials like nappies and cleaning products; and preventing social isolation by providing new clothes and shampoo.

In addition, we have proven that offering life essential goods to families and individuals pulls them towards wider services to meet additional needs such as addiction recovery, debt advice and mental health support.

■ ROBERT'S JOURNEY

Robert is a recovered drug addict.

He said: "My life was in chaos I was up to no good, committing petty crimes, getting arrested, prison. It was chaotic. Any money I had I spent it on drugs. Food was the second thing, drugs was the first.

"A charity started coming around once a week, giving me some food but also tracksuit bottoms, toiletries, warm jumpers, socks, underwear. At the time I had no money and I was still abusing.

"These goods was the start of my recovery. If I didn't have them I would have carried on doing the same old behaviour, committing petty crimes, would have carried on using substances. By people reaching out to me, made me feel like someone was there to give me some help. I started going to the charity's support groups.

"Since then I've got recovery, started doing voluntary with the charity and now I'm on the other side. I'm going out on outreach and giving it [goods from Giving World] to people that was in the same situation as me."



■ SONIA'S STORY

"I had recently come out of an abusive relationship and felt I had nowhere to turn to. I was very isolated and wasn't comfortable in attending any courses or meeting new people.

"But, if I am totally honest, I had heard that a nearby charity was offering incentives every time someone attended a session. They had a Fun Day and I received a flyer which said free goody bag for each family that attends. I really only went for that as I have three children and a grandchild living with me and we have very little money coming in so every little thing helps.

"When I entered the organisation I met nothing but friendly staff, who showed me the numerous services I could access to help me with my situation. I joined the empowering sessions and my confidence increased straight away as I felt I was being heard. I was greeted by

respect and compassion. I then joined the free make-up session course and was overwhelmed with the free brushes I had. I can now do my daughter's make up and feel I have upskilled myself.

"I was also given socks, jackets, toys and books for my children as well as reading books for myself. I am a regular member of the group now and have made lots of new friends and have regained my self-esteem. I am looking at volunteering for the group now.

"Had they not had goods on offer I would not have attended the group and would still have been at home, most likely I would have sunk into a deeper depression. Many thanks for all your help."

Giving World helped 356,594 people like Sonia in 2019... that's 977 lives on each day of the year!



IMPACTS 2019

GIFTED

GIFTED comprises structured learning workshops, peer mentoring, and volunteering sessions where adults with complex needs are encouraged to have a go, test their capabilities, and gain life and work skills. In 2019, 111 participants attended the programme. People like:

■ Susan


"Outside there is still stigma attached to mental health. I can't disclose certain things with family and friends but at the Packing Saloon I can share my experience of being an in-patient and talk about managing medication; I like coming here", Susan explains.

Susan came to the Packing Saloon, which is one of the GIFTED outreach session run at the Bradgate mental health unit in Leicester, having experienced long-term health issues complicated by strong medication. This led to Susan's admission as an in-patient on a ward at the Bradgate Unit.

"There was a lot lacking on the ward when I was an in-patient as there was little sharing of what was on offer activity-wise in the unit", Susan says. She wishes she'd known about the Packing Saloon when she was allowed to leave the ward for short spells as she feels this would have helped in her recovery and transition between being an in-patient and returning to her community.

'I'm bored at home and I want to be out talking to people, interacting with people and having something to do", Susan says following her discharge. Coming to the Packing Saloon each Thursday morning gives Susan the opportunity to build friendships, see familiar faces, share experience and give support.

Susan has always worked and would like to return to working life now she is able, ideally in a helping role. "My confidence had been knocked when I was an in-patient and the Packing Saloon has helped me to get to the next stage of applying for opportunities within mental health". She is now registered with Leicestershire Partnership NHS Trust as a support volunteer and is delighted to have been accepted to train for employment as a mental health peer support worker within the Trust.


■ Kornel


18 year old Kornel attends Westgate special needs school in Leicester. Along with his peer group, Kornel joined the GIFTED basic skills eight week workshops.

In the New Year (2019), Kornel was inspired to apply for a weekend job at Primark. Support staff helped Kornel complete the application form and to prepare when he was invited for an interview. He was successful, starting his first ever job in May 2019.

Kornel says: "GIFTED helped me a lot. When I was team leader for a session I learnt how to treat other people and team working. I also learnt to listen to instructions, how to sort stuff and fold clothes."

Elaine Braden, Westgate's Employment Support Officer said: "All the students that have attended sessions at Giving World have all come away with more confidence and a feeling of self-worth that they have done a good job, and the fact that it is helping other people, the format and structure just works!"

Trusts and other care settings
with patient care packs. The
packs include everything a
patient needs for an emergency
overnight stay.

The packs help to support the dignity and care of vulnerable patients, including women fleeing abuse, young people with mental health needs, the elderly and homeless people. We also supply comfort packs provided to carers staying with a loved one in palliative care.

Our social enterprise started following a pilot service with Leicester Hospitals Chaplaincy. Subsequent seed funding from the Department of Health expanded the service nationally, leading to the creation of PCP in 2013. We now produce/sell patients care packs to hospitals across the UK, who freely distribute the packs to vulnerable patients.

Not only is the enterprise contributing 13% of GW's annual



income, the care packs deliver significant impact for patients, nursing staff and the NHS.

Key findings from a research study into PCP's conducted by the University of Leicester:

- 94% of patients felt that PCP's ensured they felt cared for
- 84% of nursing staff felt that PCP's saved them more than 5 minutes per patient, releasing at least 40 minutes per shift, saving the NHS £1,705 per annum for very band 4 nurse
- 9 out of 10 nursing staff said being able to support vulnerable patients with PCP's improves their job satisfaction



Patients and staff alike love the packs:

- "A small thank you for the thoughtful gift left on my hospital bed on a recent emergency stay." Patient
- "Thanks for your package. My son had an emergency admission and I travelled from London not knowing what to do. The small package has helped greatly and I wish to thank you for thinking about this." *Carer*
- "The wards are really noisy as other patients make a lot of phone calls and there are lots of complaints about the noise. But with the earplugs I am able to block my ears from the noises," Patient
- "The dental kit in the pack are a life saver for keeping my teeth and breath clean," *Patient*
- "It's a brilliant idea that saves us time and allows us to provide care and support to patients..." Matron






2020 AND BEYOND....

SHARON

"I work full time nights and have four children.


"We have had a really tough year. My partner lost his job after 7 years, our landlord gave us a month's notice to move house, we had 14 days before we were all made homeless! We have now been given a home with the council. My children have also just suddenly lost their nan, who they were very close to and all the stress of the house and losing their nan has really affected them. Any help given towards my children would mean everything to me."

The short term outlook for those already struggling is unlikely to improve. We have an immediate responsibility to help the increasing numbers of desperate and vulnerable people and families.

Giving World has an impressive track record of 18 years, having created a successful delivery model that achieves more for less, joining up a trusted (and growing) network of over 6,000 UK wide donor companies and charitable distribution partners.

Our Trustee and Advisory Boards, along with our SMT are committed to strengthening our partnerships and to increasing our resource

and logistics, in order to deliver more essential life items to the communities that need them most.



Looking further ahead, 2021 will see the charity celebrating its 20th year, a momentous milestone.

We are developing plans to achieve ambitious, but crucial goals.

In 2021, Giving World's 20th anniversary, our aim is to be reaching over half a million people in need in the UK annually. By the end of 2022, the goal is to have significantly streamlined and grown operations and to be helping 2,000 people every day of the year, that's over 700,000 people annually.

Additionally making a meaningful impact for our environment by annually achieving a

saving of 13,000 tons of CO2e emissions through the distribution of over 2 million surplus products.

We recognise that surplus is a natural cycle of business but what we do with it can make a difference into our future and greatly impact the sustainability of local communities, and the UK economy as a whole.

With the support of our existing funders, our strong distribution network, the commitment of our Boards and dedicated staff, and the optimism of new supporters, we can realise benefits far greater than the sum of our individual parts, impacting many lives at a time.

The trustees, who are directors for the purposes of company law, present their strategic report for the year ended 31 December 2019, in compliance with s414C of the Companies Act 2006.

Achievements and performance

Financial review

Policy on reserves

In order to ensure operations can continue without interruption or harm to the charity's services, we aim to ensure a minimum reserves level equal to three months' operating costs, represented in the charity's free unrestricted funds.

Funds in deficit

There are no funds in deficit

Principal funding sources

Funding is received from a number of sources including grant giving Trusts and Foundations and its trading subsidiary Personal Care Packs.

Investment policy and objectives

The charity does not invest funds other than Cash Deposits with CAF. The Investment of £100 in Personal Care Packs Ltd is stated at fair value.

Trustees' Report

The trustees, who are directors for the purposes of company law, present the annual report together with the financial statements of the charitable company for the year ended 31 December 2019

Objectives and activities

Objects and aims

The company is registered as a charity and its Charitable Objects

To relieve poverty and sickness and to advance education by the provision of financial aid, grants, goods, equipment and by other such means as are exclusively charitable as the trustees in their absolute discretion determine.

We distribute new business end of line stock and equipment to people living in poverty across the UK. Essential supplies are given for free to the most vulnerable in our communities.

Objectives, strategies and activities

In 2019 we redistributed 1,109,615 (2018 1,088,211) brand new business surplus products to 356,594 (2018 303,335) people in need.

Public benefit

Giving World's only mandate is to help people in need through the distribution of business surplus products for free to communities in need.

The trustees confirm that they have complied with the requirements of section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission for England and Wales.

Going concern

The Charity is adequately funded and there are no material uncertainties with the ability to continue of the value of assets.

Structure, governance and management

Nature of governing document

The charitable company is constituted under a Memorandum of Articles and is governed by its Articles of Association. The liability of its members in the event of the company being wound up is limited to £1.

Recruitment and appointment of trustees

Prospective new trustees are invited to attend meetings informally to gain an understanding of the organisation and their role and responsibilities. New trustees are given copies of the charity's legal documents, management information and accounts, together with general reading material about the charity and Charity Commission literature. This is followed by meetings with the Chair and other Trustees.

Arrangements for setting key management personnel

Key Management is involved in the distribution of surplus product, income generation and organising of volunteers with remuneration set by Trustees.

Organisational structure

Strategic Governance is through the Charity Trustees who set the overall parameters for the organisation, ensures it meets its charitable objectives and produces an annual report. Day to day management is allocated to two Directors. The current team of trustees and directors are experienced community members with a range of financial, banking and business development experience.

Relationships with related parties

Personal Care Packs Ltd

Personal Care Packs Ltd distributes by way of gift aid funds received from the supply and distribution of Health Care

Financial instruments

Objectives and policies

The charity's activities expose it to a number of financial risks including credit risk, cash flow risk and liquidity risk. The use of financial derivatives is governed by the charity's policies approved by the board of trustees, which provide written principles on the use of financial derivatives to manage these risks. The charity does not use derivative financial instruments for speculative purposes.

Trustees' Report (Cntd.)

Cash flow risk

Interest bearing assets and liabilities are held at fixed rate to ensure certainty of cash flows.

Credit risk

The Charity's principal financial assets are bank balances and cash, trade and other receivables, and investments. The credit risk on liquid funds and derivative financial instruments is limited because the counterparties are banks with high credit-ratings assigned by international credit-rating agencies. The Charity has no significant concentration of credit risk, with exposure spread over a large number of counterparties and customers.

Liquidity risk

Further details regarding liquidity risk can be found in the Statement of accounting policies in the financial statements.

Employment of disabled persons

The Company operates an equal opportunities policy.

Creditor payment policy

Payments are made within 30 days to suppliers.

Statement of Trustees' Responsibilities

The trustees (who are also the directors of Giving World for the purposes of company law) are responsible for preparing the trustees' report and the financial statements in accordance with the United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) and applicable law and regulations.

Company law requires the trustees to prepare financial statements for each financial year. Under company law the trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charitable company and of its incoming resources and application of resources, including its income and expenditure, for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and

 prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charitable company's transactions and disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Giving World

2. Accounting policies

Summary of significant accounting policies and key accounting estimates

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Statement of compliance

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102). They also comply with the Companies Act 2006 and Charities Act 2011.

Basis of preparation

Giving World meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

Going concern

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern nor any significant areas of uncertainty that affect the carrying value of assets held by the charity.

Exemption from preparing a cash flow statement

The charity opted to early adopt Bulletin 1 published on 2 February 2016 and have therefore not included a cash flow statement in these financial statements.

Income and endowments

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of the income receivable can be measured reliably.

Grants receivable

Grants are recognised when the charity has an entitlement to the funds and any conditions linked to the grants have been met. Where performance conditions are attached to the grant and are yet to be met, the income is recognised as a liability and included on the balance sheet as deferred income to be released.

Investment income

Dividends are recognised once the dividend has been declared and notification has been received of the dividend due.

Expenditure

All expenditure is recognised once there is a legal or constructive obligation to that expenditure, it is probable settlement is required and the amount can be measured reliably. All costs are allocated to the applicable expenditure heading that aggregate similar costs to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use. Other support costs are allocated based on the spread of staff costs.

Charitable activities

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Grant provisions

Provisions for grants are made when the intention to make a grant has been communicated to the recipient but there is uncertainty about either the timing of the grant or the amount of grant payable.

Governance costs

These include the costs attributable to the charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustees's meetings and reimbursed expenses.

Taxation

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Tangible fixed assets

Individual fixed assets costing £1000 or more are initially recorded at cost, less any subsequent accumulated depreciation and subsequent accumulated impairment losses.

Depreciation and amortisation

Depreciation is provided on tangible fixed assets so as to write off the cost or valuation, less any estimated residual value, over their expected useful economic life as follows:

Unrealised gains and losses represent the movement in market values during the year and are credited or charged to the Statement of Financial Activities based on the market value at the year end.


